Subject: Reactive Energy under ABT regime-for the period 15.02.10 to 21.02.10 -Reg.

महोदय,

Sir,

रिएक्टिव ऊर्जा का लेखा ज 15.02.10 से 21.02.10 के लिए भेजा जा रहा है, जिसमे लाभार्थियों के बीच एवं कथित लेखा मे देय / प्राप्तकर्ता का ब्योरा दिया गया है। रिएक्टिव ऊर्जा की दर IEGC - दिसंबर 2005 अंक की खंड 1.7 के अनुसार होगी, जो कि 1 अप्रैल 2006 से 5.0 पैसा प्रति KVARH बनता है और फिर यह दर 0.25 पैसे प्रति वर्ष से बढ़ती रहेगी । तदनुसार यह दर 1.4.2009 से 5.75 पैसा प्रति KVARH हो जाती है ।

The statement of Reactive Energy account giving details of payables/receivables with the pool and between beneficiaries in rupees for the period 15.02.10 to 21.02.10 is sent herewith. The rate for charge/payment for reactive energy will be governed as per clause 1.7 of IEGC-December 2005 issue, which works out to be 5.0 Paise/KVARH w.e.f from 1st April 2006, computed @ 0.25 Paise escalation per year i.e. 5.75 Paise/KVARH at present w.e.f 01.04.2009.

संघटकों द्वारा बिलिंग रकम का अग्रिम भुगतान, बिलिंग तिथि के 10 दिन के भीतर करना होगा । संघटक द्वारा इस बिल का 12 दिनों के पश्चात भुगतान करने पर, संघटक को 0.04% प्रतिदिन के अनुसार IEGC (दिस 2005) अंक के पूरक बाणिज्यिक मैकेनिजम के तहत अनुच्छेद 6 एवं 7 के अनुसार साधारण ब्याज हर बिलबिल दिन के लिए देना होगा । आर.इ.ए लेखा का सम्पूर्ण ब्यौरा उ.पू.क्षे.वि.स की वेबसाईट www.nerpc.nic.in पर भी उपलब्ध करा दिया गया है ।

Further the payment by the constituents for the billed amount shall be made within ten days of the billing date. In case of delayed payment against these bills beyond twelve days, the defaulting constituents shall have to pay simple interest @ 0.04% for each day of delay vide clauses-6 & 7 under complimentary commercial mechanism of IEGC (December 2005) issue.


