दिनांक 25.12.17 से 07.01.18 (2 weeks) की अवधि का रिएक्टिव एनर्जी लेखा जिसमें पूल और हितधारियों के बीच देय / प्राप्तियोग्य विवरणों को इसके साथ भेजा जा रहा है | रिएक्टिव एनर्जी के प्रभार/ भुगतान IEGC-April 2010 के उपबंध 6.6(2) के अनुसार शासित होंगे जो कि 1 अप्रैल 2017 से 13.5 पैसे/केवीएआरएच होग, इसके बाद प्रति वर्ष 0.5 पैसे परिकलित किया जाएगा जबतक कि अन्यथा आयोग द्वारा संशोधित न किया जाए |

The statement of Reactive Energy account giving details of payables/receivables with the pool and between beneficiaries in rupees for the period 25.12.17 to 07.01.18 (2 weeks) is sent herewith. The rate for charge/payment for reactive energy will be governed as per clause 6.6 (2) of IEGC-April 2010 issue, which works out to be 13.5 Paise/KVARH w.e.f from 1st April 2017, computed @ 0.5 Paise escalation per year thereafter, unless otherwise revised by the Commission.

Further the payment by the constituents for the billed amount shall be made within ten days of the billing date. In case of delayed payment against these bills beyond twelve days, the defaulting constituents shall have to pay simple interest @ 0.04% for each day of delay vide clauses 11&12 under complimentary commercial mechanism of IEGC (April 2010) issue.

Utilities may please note that meter readings at both the ends are not available in case of some of the transmission lines and Reactive Energy account has been prepared based on available information.
